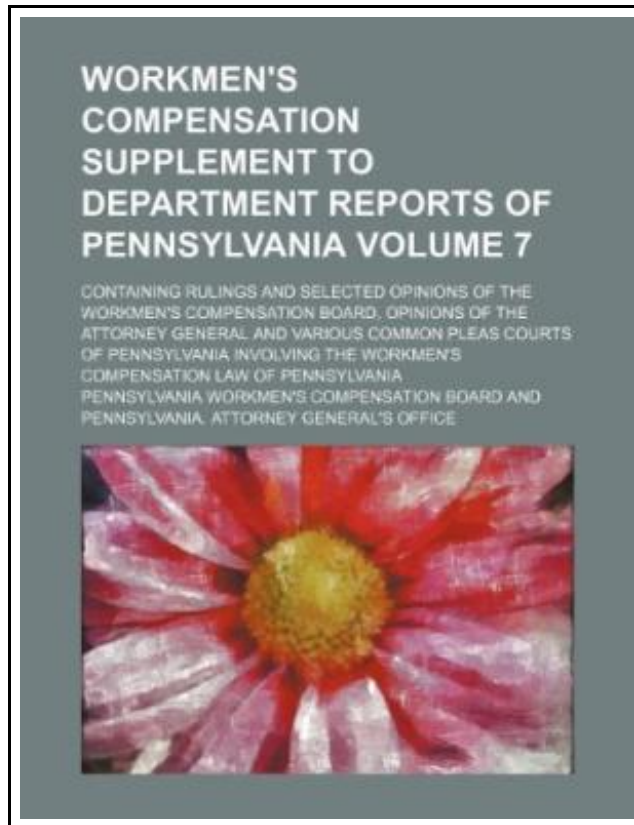

MACKEY, Chairman, Nov. 18, 1921: Raymond Fay, the elaimant, was employed by the defendant, the Pennsylvania Railroad Company as a flagman, on August 22, 1920, at an average weekly wage in excess of 20. 00. Upon the aforesaid date the claimant sustained injuries by accident, in the course of the employment, to his right leg and hip, which totally disabled him from the date of the accident until December 1, 1920. FIRST: The accident occurred at the E. J. Tower near the West Elizabeth Station at 12: 25 P. M. on August 22, 1920. The claimants duties as a flagman took him upon a train going north; he...
